## Negotiated Rulemaking Committee (NRMC): Data Request Reevaluation

Texas Education Code 51.406 directs THECB to:

- reevaluate its rules and policies to ensure the need for data it requests from IHEs and
- consult with IHEs to identify any unnecessary data requests for removal from Board rules

NRMC formed to consult with THECB on tasks:

- THECB staff compiled list of 93 data requests and reports routinely required of all IHEs or IHEs in a sector
- Staff proposed a second list that identified 14 of the 93 for NRMC discussion and possible modification or deletion



### NRMC/THECB Review Process

NRMC convened at THECB 12/5/2017 to make recommendations on proposed THECB and any other data requests or reports its members proposed:

 28 total data requests and reports proposed for modification or deletion

Afterwards, THECB status of NRMC recommendations includes:

- 7 requiring potential statutory change
- 4 Board rule changes
- 7 require determining feasibility of process changes
- 4 result in CBM manual changes
- 5 receiving work group study



### NRMC Data Request Reevaluation: Summary

#### **HB 400 School Districts**

- HB 400 report for TEA
- Similar to the THECB HB 2550 high school report
- HB 2550 report can serve both purposes
- Review/modify TEC 29.904 (amended by HB 2223, 85<sup>th</sup> R.S.) and/or TEC 51.810, 83rd

#### **Affordability and Access**

- Required of IHEs for preceding fall, spring, summer semesters – too frequent
- IHEs report narrative data on online form
- THECB populates numerical data
- Review/modify TEC 51.4031



### Sample NRMC Recommendations Requiring Statutory Changes (cont.)

#### State-funded Campus-based Programs

- Eliminate duplicative items about excess funds on FADS
- Determine data still needed to meet public demand
- Review/modify TEC 54.5021

#### **Community College Transfer Student Requirement**

- Eliminate annual GAI survey reporting
- Delete 60 SCH transfer definition
- THECB continues writing annual report based on CBM data
- Review/modify SB 1, 85th, Sec. 49, 888-269 [Note. Rider No. changes biennually]



Negotiated Rulemaking Committee manual changes, Simple Deletions:

- CBM008 Faculty Report Delete New Hire Item 19 for Universities, Item 12 for CTCs and Item 16 for health related institutions (HRIs)
- CBM00B Admissions Report Delete Items 15, 16 and 20 related to parental education and family obligations
- CBM001 Student Report Delete Item 22E Programs to Eliminate Gender Bias affecting the CTCs
- CBM00A Continuing Education Student Report Delete Item 22E Programs to Eliminate Gender Bias affecting the CTCs
- Manual Deletions will be scheduled for fall 2018



Negotiated Rulemaking Committee manual changes, Combine Items:

- CBM001 Student Report Delete Item 10B SCH Load, Off-Campus affecting the Universities (and combine the off-campus and on campus hours in Item 10A)
- CBM001 Student Report Delete Item 11 SCH Remote Site for the HRIs (and combine the offcampus and on campus hours in Item 10)
- Manual Update for Combined Items will be scheduled for Fall 2019



## *Proposal* for timely submission of data

- Internal THECB working group delved in to the underlying drivers of late submission and surfaced possible strategies for improvement
- 2+ year effort designed to achieve:

100% of fall CBM reports collected by EDC are certified by the institutions as available for use within **SIX** working weeks of the due date. (appx Dec 1)



## Suggested strategies for timely submission of data

- Revise certification notification process in manuals
  - Shift from focus on due date to focus on certification date
  - Move from four weeks to six weeks for certification post due-date
  - Standardize and automate process of notifications, for example....
    - Call to operational contact
    - Email to reporting official
    - Email to president
- Increase transparency around timeliness of data submission and audit risk



### Suggested strategies

- Improve edit check reports to provide more guidance on issues
- Develop a best practices resource
  - Strategies for the timing and process of changing student information systems
  - Troubleshooting common errors
- Develop tools to enhance accuracy of reporting
  - Open the 00S earlier
- Honor those who meet deadlines

### 8-week course reporting

- 8-week courses are associated with improved student success
- Odessa College has implemented this model at scale
- Now, we would like to support scaling by other institutions by modifying reporting and formula funding runs to better include 8-week courses



## *Proposal* to Legislative Budget Board (LBB) for 8-week course reporting

- 2<sup>nd</sup> 8 week courses must be certified by deadline of 6 weeks after initial published reporting due date
- *Proposed* modifications to formula runs
  - Preliminary Base-Year Run
    - Previous Spring Certified
    - Summer 1 Certified
    - Summer 2 Certified
    - Current Fall 1 Error Free
    - Previous Fall 2 Certified
  - Final Base-Year Run
    - Previous Summer 1 Certified
    - Previous Summer 2 Certified
    - Fall Certified
    - Spring 1 Error Free
    - Previous Spring 2 Certified

# 60x30TX regional targets promote regional mobilization and strategy development

- Regions and institutions differ in many ways. Institutional actions and outcomes are embedded in regional context.
- THECB has identified regional targets in three areas:
  - ✓ 60x30 Educated Population Goal
  - Completion Goal of 550,000 certificates, associate, bachelor's, and master's degrees
  - ✓ 65% High school-to-higher education direct enrollment
- Regions are convening locally to identify "best bet" strategies by August 2018
