

We have passed the mid-term period for spring 2018....time really does pass more quickly the older you get!


Our South Padre Island time seems like a distant memory now. We wrapped up the Conference with the LAC audit during the first week of April.

It was a great day full of collegiality, good food, very relevant/helpful information, and sharing of ideas. East Texas Baptist University will be hosting the 2019 meeting.

East Texas Baptist University (ETBU) has experienced a lot of "new" since our last newsletter. In December, we set a new record for graduates. Northeast Texas Community College

In a unanimous decision at its December meeting, the Board of Trustees for Northeast Texas Community College voted to appoint **Dr. Ron Clinton** as president of the college. For the previous nine years, Dr. Clinton had served as the Executive Vice President for Instruction. Dr. Clinton's association with Northeast began in 1984, when the college first opened its doors to students. He served as a faculty member for music, humanities, and philosophy for many years prior to moving into an administrative role. Clinton holds Master's and Doctor's Degrees from the University of Texas at Austin, and earned his Bachelor of Fine Arts from Stephen F. Austin State University. He is the fifth president of NTCC since the college opened in 1984, and succeeds **Dr. Brad Johnson**, who served as president for nine years until September 2017. A search is currently underway to identify a replacement for Dr. Clinton's previous position in the Vice President for Instruction office.

Stephen F. Austin State University men's basketball team made another appearance in the March Madness NCAA tournament, giving the Texas Tech Red Raiders a run for their money. SFA was recently ranked as one of the safest colleges in America by the National Council for Home Safety and Security.

The Registrar's Office, in conjunction with Financial Aid, implemented Courses that Count in Program of Study (CPoS) functionality. Campus-wide implementation of Banner 9 is planned for fall 2018.

Texas Tech University: On March 8th, 2018, the Office of the Registrar at Texas Tech University hosted a FERPA Training presentation, featuring guest speaker AACRAO Senior Fellow, **LeRoy Rooker**. We had an outstanding turn out, with more than 120 attendees from over 35 departments and offices across the university campus. During the event, Mr. Rooker covered a variety of topic areas regarding FERPA compliance and best practices for universities, colleges, and departments. Mr. Rooker's presentation allowed us, as a Texas Tech community, to expand our breadth of knowledge on various FERPA topics and implications for institutions of higher education. Most importantly, this event provided a very positive means for the TTU Registrar's Office to support the greater efforts of our campus, and help to identify areas for improvement.



FERPA is a fundamental part of what we do, and having the opportunity to learn directly from Mr. Rooker was an invaluable experience. This event allowed the Registrar's Office to develop extensive documentation of potential improvements in how we provide guidance and support for FERPA compliance among our campus partners. We would like extend a very special thank you to Mr. Rooker for his willingness to share his time, expertise, and vast knowledge of FERPA with the Texas Tech University community.

Amarillo College has formed a partnership with Texas Tech University to expand horticultural studies in the Texas Panhandle, [reports The Amarillo Globe-News](#). The announcement comes as Amarillo College prepares to open an impressive new greenhouse facility. The Texas Tech partnership will open a pathway for Amarillo College students to finish an entire 4-year bachelor's degree in plant and soil science from Texas Tech, without ever leaving the Amarillo campus. The new \$2 million greenhouse laboratory facility will be located at the college's Washington Street campus. Students will also be able to choose a two-year associate's degree program in horticulture. The new partnership will also open up research opportunities between students at the two schools.

A New Day Dawns for **Texas State Technical College** in Abilene (#TSTCbiggerandbetter). That's the social media hashtag the marketing team is using to promote our growing presence and new building in Abilene. But the term is so much more than just a promotional tag. With construction on TSTC's Industrial Technology Center to be completed in early July near Abilene Regional Airport, TSTC is poised to better serve the students and workforce of the region. 
April Clanton has been promoted from Commencement & Course Action Process Coordinator to Assistant Registrar over Curriculum, Catalog and Commencement.
